### RULES & REGULATIONS

- 1. BOOTH SPACE** is approximately 10 feet x 10 feet. The booth spaces are on asphalt and concrete surfaces. If accepted, this application only includes the booth space. Booth construction such as canopies, poles, security side curtains, display tables, etc...are the responsibility of each vendor. Vendors shall not encroach outside the boundaries with any items. No storage boxes may be visible and all booths shall be kept in a clean and tidy manner during the entire event.
  - 2. BOOTH SETUP/BREAKDOWN.** All vendors may begin setting up their booths the day of the event after 6 AM, and must be completely set up and ready for inspection by the La Mesa Fire and Police Dept. representative no later than 8 AM. Those wishing to unload onto the venue may do so between the hours of 6AM AND 7AM. Items must be unloaded onto the sidewalk near your space until the street marking is complete. After 7AM, no cars will be allowed on the Boulevard. Booth breakdown shall begin promptly at 5:01 PM and booths should be vacated by 6 PM. Each vendor shall police his area for trash, debris, and paper and shall broom sweep the space before leaving.
  - 3. DISPLAY SALES/SPACE POLICY.** Reproductions or new items are not allowed-genuine Antiques & Collectibles only! Show management shall be the sole judge of acceptability.
  - 4. SECURITY/PARKING.** Parking is limited and there is no reserve parking for booth vendors. Vendors should bring their own hand dollies for setup. Vendors shall not park in alleys, fire lanes or tow away zones at any time.
  - 5. SELLERS PERMIT REQUIRED.** Included in your booth fee is a Special Event Business License that is issued by the City of La Mesa, State law requires that each vendor have a valid seller's permit. If you do not have one, please call (619) 525-4526.
  - 6. REFUNDS.** No refunds will be made after the application is accepted. Nor will they be made in the event of inclement weathers, acts of nature or by restrictions imposed by government agencies which may cause cancellation of the event. All booth vendors are responsible for their items of value and articles in their possession including loss, theft and damage.
  - 7. BOOTH CONSTRUCTION.** Wood, plastic/vinyl tarps, heavy canvas and shade cloth are allowed for booth construction. All other material shall be treated with a fire retardant by a Certified Flame Retardant Applicator or the vendor must have a Certificate of Flame Resistance in the booth for review by the Fire Department Representative. Please note – ALL FABRIC TABLECLOTHS MUST HAVE A CERTIFICATE OF FLAME RESISTANCE.
  - 8.** We strongly suggest that booth vendors provide a 2AIOBC Fire Extinguisher in their booth for personal safety.
